**Umpires:** ANC Umpires are currently being organised by RI (included in fees)

**Transport:** Parents/Players are responsible for organising transport to and from the courts

**Uniform:** RI Netball Uniforms for all players are available for purchase directly through the Uniform Shop in Remuera for \$60 (Dress/Bike Pants). Samples will be available at school for sizing along with measurements on the Uniform Shop website.

**Player Fees:** The fee for the season is \$80 per person which includes registration, umpire's fees and equipment for each team. This must be **paid in full** through the school portal or at the office by **Mon 4th of April** and is not required to be paid until after trials. (Subject to change, depending on registration costs)

**Coaches/Managers:** Each team is responsible for arranging their own coach and manager.

**Please Note: Teams will only be registered once all members have paid in full and a coach and manager have been confirmed.**
